Dear Prime Minister and Minister Mahuta,

We write this open letter requesting that the Government of Aotearoa New Zealand take leadership in support of the Vanuatu Government and the campaign for an Advisory Opinion from the International Court of Justice ('ICJ') on human rights and climate change.

Your Government has already indicated general support, but more can and must be done as a matter of urgency. The Government expressed 'in principle' support for an ICJ Advisory Opinion on the climate change obligations of states, in a 2019 communication to the leadership of Pacific Islands Students Fighting Climate Change (PISFCC).¹ A letter from Minister Mahuta to PISFCC (4 October 2021) went further.² Climate change was identified as a "first order priority for Aotearoa New Zealand". This letter expressed an intention to work closely with Pacific Island partners to "seek ambitious action". It also affirmed that an ICJ Advisory Opinion on climate change and human rights would be a "significant development" and acknowledged its potential as a "constructive proposal" that draws attention to the urgency of climate change. Finally, this letter referred to United Nations

General Assembly discussions and a willingness to engage with Vanuatu and Pacific partners.

The purpose of this letter is to ask your Government (as a matter of urgency) to increase your efforts in support the ICJ Advisory Opinion initiative. This could be achieved by working constructively with Vanuatu and likeminded governments to raise awareness and actively build the necessary coalition of supportive states in the Pacific region and internationally. Ensuring the initiative is on the agenda at forthcoming meetings such as the upcoming Pacific Island Forum and Commonwealth Heads of Government Meeting will also be important. Leadership in support of Vanuatu's proposal should extend to engaging directly in the drafting the legal question (in due course), with a view to becoming a co-sponsor of the necessary United Nations General Assembly Resolution.

In the period since October 2021, much as been achieved by Pacific Island youth who began the campaign and their international supporters. It is now a global youth campaign, co-led by World Youth for Climate Justice. They have been working hard to raise global awareness of the constructive value of an Advisory Opinion. In March this year, the Conference of Heads of Government of the Caribbean Community (CARICOM) expressed their support for the efforts of Vanuatu.³ On 5 May 2022 the Prime Minister of Vanuatu launched the global civil society campaign.⁴ Momentum is building but more can be done by your Government to actively support this initiative within and beyond the Pacific region.

In the mid 1990s a generation of our political leaders had the wisdom and foresight to actively support a civil society initiative that resulted in an Advisory Opinion from the International Court of Justice on the legality of the threat or use of nuclear weapons. The resultant 1996 Nuclear Weapons Advisory Opinion became a landmark legal decision. As the political leaders of today we are calling upon you to demonstrate Aotearoa New Zealand's active commitment to intergenerational justice. Humanity faces a climate emergency, the existential risks and threats to peace and security are as real and as avoidable as those posed by nuclear weapons.

Your Government has frequently employed concepts of intergenerational justice in policy and law. It has supported its use in a growing number of statutes, including the Climate Change Response (Zero Carbon) Amendment Act 2019. The Government of Aotearoa New Zealand holds intergenerational responsibility for the peoples of this nation and of the

Pacific. It also espouses the value and significance of kaitiakitanga.⁵ Proactive leadership in support for an ICJ Advisory Opinion would (to quote the Prime Minister) ensure our nation 'tackles head on' this generation's 'nuclear free moment'.⁶
